## Synopsis of some Rules

These synopses are offered to wet your appetite for further study and application. Space does not permit me to write more extensively as well as there are many resources available both in book form and on the internet.

### Rule of 20 or some play Rule of 19

This rule states that you add the length of your two longest suits to your high card points (HCP) and if 20 (19) or more you <u>may</u> open the bidding, thus with a 5-4 distribution and 11 (10) HCP. For longer distributions such as 5-5 and 6-5, you will need to have 10 HCP to conform to the ACBL regulation on ALERTS that an opening bid at the 1 level promises 10 -21+ HCP. If you have a partnership agreement for these latter distributions, then you must alert that opening bids may be distributional and less than HCP. In using this rule, especially in first or second seat, you need to consider what your rebid will be after a response from partner.

### Rule of 15

This rule states that you add the length of the spade suit to your HCP and if 15 or more then you <u>may</u> open the bidding in fourth seat after 3 passes to you. The concept is that spades is the controlling suit, the HCP are almost evenly distributed among the four hands, and it may hinder the opponents from entering the auction. If the total is less than 15, fourth seat passes out the deal. There may be hands were you have a choice of this rule or the rule of 20 above, in which case it makes more sense to apply the rule of 15; for example you have the HCP and distribution for Rule of 20, but not the spade suit or a good biddable suit which has defensive values because the HCP are concentrated in the minor shorter suits.
