♦ Law 17 the Auction Period

- ♥ The auction period begins when players withdraw their cards from the board.
- Dealer makes the first call and then proceeds around to the left.
 - A call is any one of the following: Pass, Double, or Redouble (Law 18.A).
 - A bid states the number of tricks from one to seven and the denomination, i.e. suit or no trump (Law 18.A).
- **♥** The auctions period ends when (Law 17.E and Law 22):
 - All four players pass. No redeal is permitted.
 - Three players pass consecutively after one or more players have bid. The last bid becomes the contract.
- Some Irregularities:
 - Exposed cards Law 24:
 - A card is exposed when the face may be seen by the partner.
 - Single low card not prematurely led, such as falls out of hand, there is no further rectification.
 - Offender's partner must pass when his next turn to call.
 - Single honor card exposed or prematurely led,
 - ♠ When two or more cards are exposed,
 - ♠ Any card is led prematurely.
 - If the pass damages the non-offending side, an adjusted score may be awarded.
 - Pass out of rotation if no player has bid:
 - ♣ LHO may accept the call; and there is no further rectification.
 - **.** LHO does not accept the call, the call reverts to the proper player and the offender must pass at his next turn to call.
 - Pass out of rotation after a player has bid:
 - If offender's RHO's turn to call, offender must pass at his next turn to call.
 - ♣ If offender's LHO's turn to call, the call is treat as a change in call.
 - If partner's turn to call, offender must pass from this point; partner may make only any bid or pass.
