Doubles and Redoubles

- ♠ A player may **double** only the last preceding bid. That bid must have been made by an opponent, and calls other than pass must not have intervened, Law 19.A.1.
 - ♥ The only the word "**double**" may be used, or with bidding boxes the red single X card, Law 19.A.2.
 - ♥ If any other words are used, such as the number of tricks or denomination are stated Law 16, Unauthorized Information may apply. Law 19.A.3.
- ♠ A player may **redouble** only the last preceding double. That bid must have been made by an opponent, and calls other than pass must not have intervened, Law 19.B.1.
 - ♥ The only the word "**redouble**" may be used, or with bidding boxes the dark blue double XX card, Law 19.B.2.
 - ♥ If any other words are used, such as the number of tricks or denomination are stated Law 16, Unauthorized Information may apply, Law 19.B.3.
- ♠ Any legal bid supersedes a double of redouble.

Inadmissible Doubles and Redoubles

- ♠ A double or redouble not permitted by Law 19, Law 35 A.
- ♠ An inadmissible double or redouble may never be accepted, Law 32.
 - ♥ A double without a preceding bid is inadmissible.
 - ♥ A double of partner's bid is inadmissible.
 - ♥ A double by bidder's right-hand-opponent (RHO) is a call out of rotation
 - ♥ A redouble without a preceding double is inadmissible.
 - ♥ A redouble of partner's double is inadmissible.
 - ♥ A redouble by doubler's RHO, i.e. the bidder, is a call out of rotation

Restoration of Equity

- ♠ An inadmissible double or redouble is cancelled as well as any calls made after it, Law 36.
 - ♥ Offender's LHO calls before rectification: the calls are cancelled; the call reverts back to the correct player to call; and the auction proceeds as if no there was no irregularity.
 - ♥ Offender's LHO does not call before rectification: the offender must substitute a legal call and his/her partner must pass whenever it is his/her turn to call.
- ♠ A double or redouble made out of rotation
 - ♥ May be accepted by offender's left-hand-opponent (LHO).
 - ♥ If not accepted, the out of rotation call is cancelled, and:
 - ♦ Offender's partner's turn to call, the partner must pass whenever it is his/her turn to call.
 - ♦ Offender's RHO's turn to call;
 - ♣ If RHO passes, Offender repeats his call and no further rectification, Law 26 lead restrictions don't apply.
 - ♣ If RHO makes any legal call, Offender may make any legal call and is partner must pass whenever it is his/her turn to call. Law 26 lead restrictions may apply.
