♠ **Nov 7th Monday ACBL membership game Open Pairs:**

To earn 81.8% sectionally rated black masterpoints in this game **BOTH** players of a pair must be paid members of the ACBL. Non-members and non-paid members are welcome to play but will not be awarded masterpoints, thus if you are interested in earning masterpoints, please join or renew your membership in the ACBL which is easy to do online at <http://www.acbl.org>. ♥ **Restructure of Wednesday Game Survey**

In January, it will be 7 years that the Wednesday Invitational game will have been in operation with its limit of one player of a pair having less than 500 masterpoints and being a non-life master. The players have grown in their skills and accumulation of masterpoints such that it is time to reconsider the configuration of the game operation. Thus, we would like to consider a two-section configuration starting in January:

1. Open section with unlimited masterpoints for players of a pair.
2. Invitational section limited to both players of a pair having less than 500 masterpoints and being non-life masters. This section will require a minimum of three tables to be viable, otherwise players will play in open section.

Since the games exists for you the players, we are asking for your input in what you would like forgoing by completing the following survey.

♦ **Law 62 Correction of a Revoke**

- ♣ Revoke must be corrected
 - ♠ A player must correct his revoke if he becomes aware of the irregularity before it becomes established.
- ♣ Correcting a revoke.
 - ♠ To correct a revoke, the offender withdraws the card he played and substitutes a legal card.
 - ♥ A card so withdrawn becomes a major penalty card (Law 50) if it was played from a unfaced hand.
 - ♥ The card may be replaced without further rectification if it was played from declarer's hand or dummy's hand.
 - ♠ Subsequent card played
 - ♥ A claim of a revoke does not automatically warrant inspection of quitted tricks.
 - ♦ Quitted tricks may not be inspected (except at the Director's specific instruction).
