▲ December the Month of Light

December Holidays in religious traditions have celebrations involving light. Buddhist friends celebrate Bodhi Day December 8 commemorating Buddha's enlightenment. Jewish friends start the month with Hanukkah from Dec 16-24 in remembrance of one's day oil lasting eight days in the rededication of the temple in 165 BCE. ♦ Premature Lead or Play: Law 57

- A defender leads to the next trick before partner has played to current trick.
- ♥ A defender plays out to turn before partner has played.
 - The card led or played as in above, is a major penalty card
 - Declarer's selects options one of these three options
 - Require offender's partner to play the highest card he holds of the suit lead.
 - A Require offender's partner to play the lowest card he holds of the suit lead.
 - Forbid offender's partner to play a card of another suit specified by declarer.
- A defender is not subject to rectification for playing before his partner if
 - If declarer has played from both hands
 - Dummy has played a card or illegally suggested that it be played.
- A singleton or one of cards adjacent in rank of the same suit is not considered to be played until declarer has instructed or indicated that the card be played.
- A premature play that is not a lead by declarer from either hand is a played card and may not be withdrawn.
