7. "Rule of N": A hand with 11 High Card Points and 5-4-3-1 distribution would meet the "Rule of 20" (11 + 5 + 4 = 20), but not the "Rule of 21" or higher.

Alert Changes: in the January 2021 Bridge Bulletin the following announcement was noted. "The ACBL Board of Directors unanimously approved a comprehensive update to the ACBL Alert Procedure at their November meeting, the first major overhaul in 20 years. The new procedure goes into effect Jan.1, 2021. The full document is available at acbl.org under the Tournament tab. Look for the green Alert Procedures tab." If you are playing online, you should be using and when we reopen, you will be expected to be in compliance. As with anything new, you will need to work at it realizing that mistakes will be made until it is ingrained.

Using the Chrome browser this was the steps once I opened the ACBL home page:

- 1. Click on Tournaments.
- 2. On the left click on **Helpful Documents**.
- 3. Then under the heading **Tournaments**: click on **Alert Procedures**.
- 4. Also listed under this heading is the <u>New Convention Charts (effective 11/22/18)</u>. This is the 2/12/2020 revision from which the information for the newsletter has been taken. This revision may also be found at (http://web2.acbl.org/documentLibrary/about/CONVENTIONCHARTS2_2020.pdf).

The **rules for Alerts** change when playing online. Appendix O (https://web2.acbl.org/documentLibrary/play/AppendixO.pdf).

The following are quoted from the 11/8/2020 Alert procedure:

The **objective of an Alert** is to indicate to the opponents that the meaning of a call is unexpected. In an ideal world we would just Alert "what the opponents don't know." In the real world, we don't know what the opponents know, so we must use a set of rules instead.

Alerts must be made verbally by saying the word "Alert" and visually by tapping the "Alert" strip or showing the "Alert" card in the bidding box. When a call has been Alerted, an opponent, at their turn to call may ask about its meaning. The preferred form of the question is a simple "Please Explain."

Penalties for failing to Alert are not automatic. However, a player who is misinformed by an opponent's failure to Alert will be protected. A player who does not ask about an Alerted call will not be protected, even if the meaning of the call is not what they expect.
